# Why has the EUTF for Africa been established?

- To ensure **greater coordination** between the EU and other actors; and a more integrated approach in addressing irregular migration and forced displacement
- As a joint, **swift and flexible response** to deliver immediate and concrete results
- As an additional tool to the EU development cooperation already contributing towards **tackling the root causes of migration**
- To **coordinate actions** between the north of Africa and the other two windows of Sub-Saharan Africa.

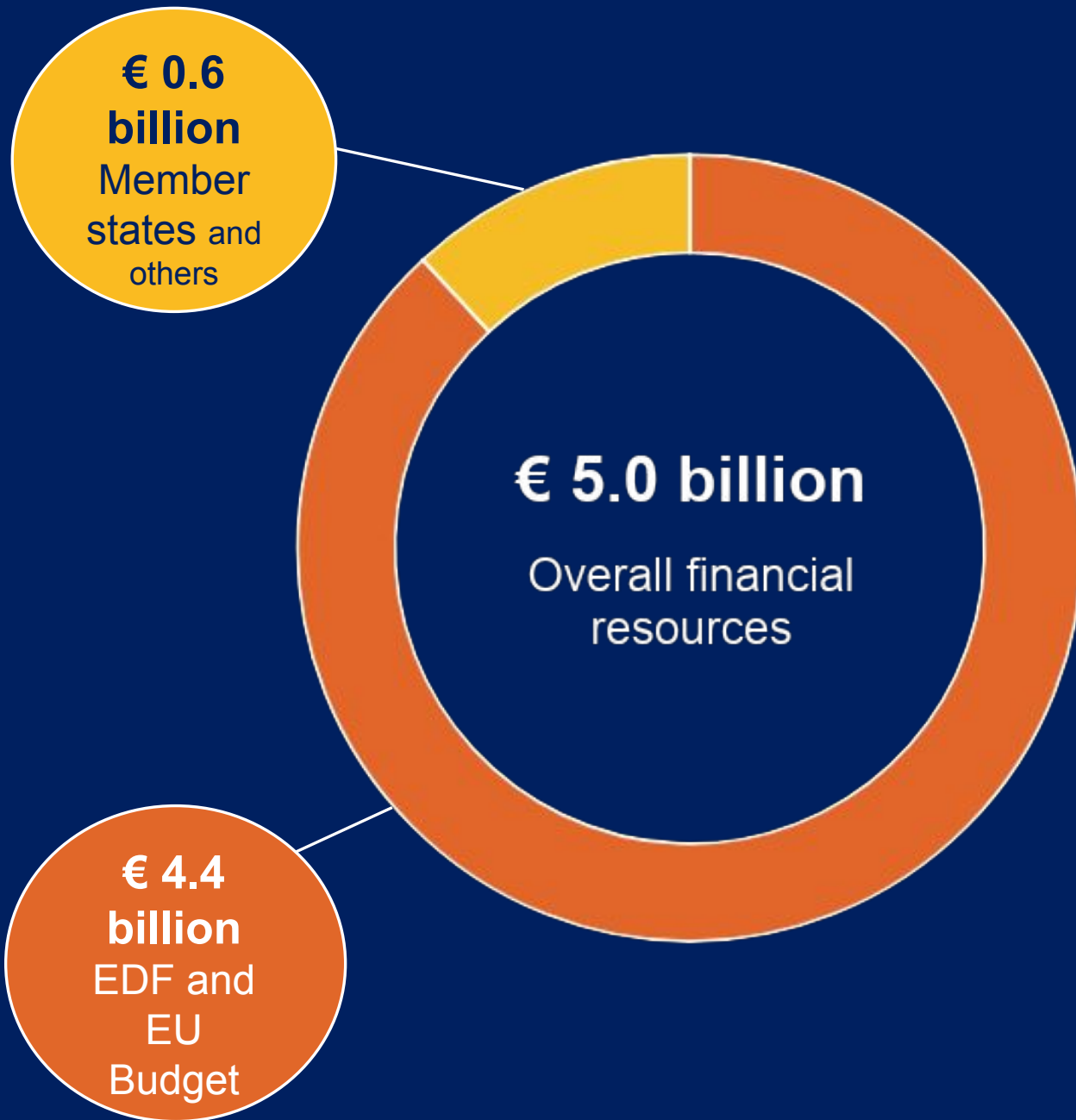

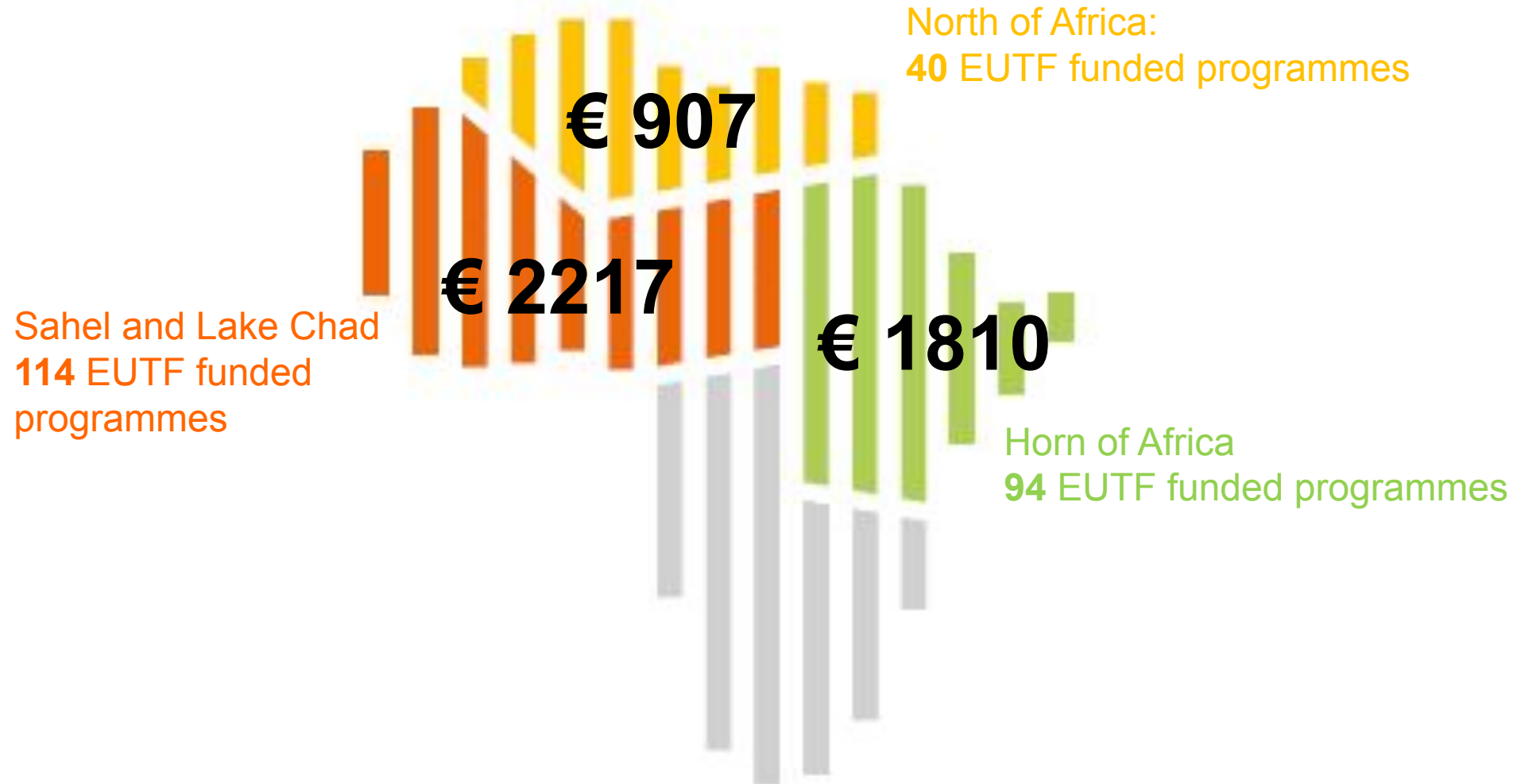

Total approved: **€4.9 billion**

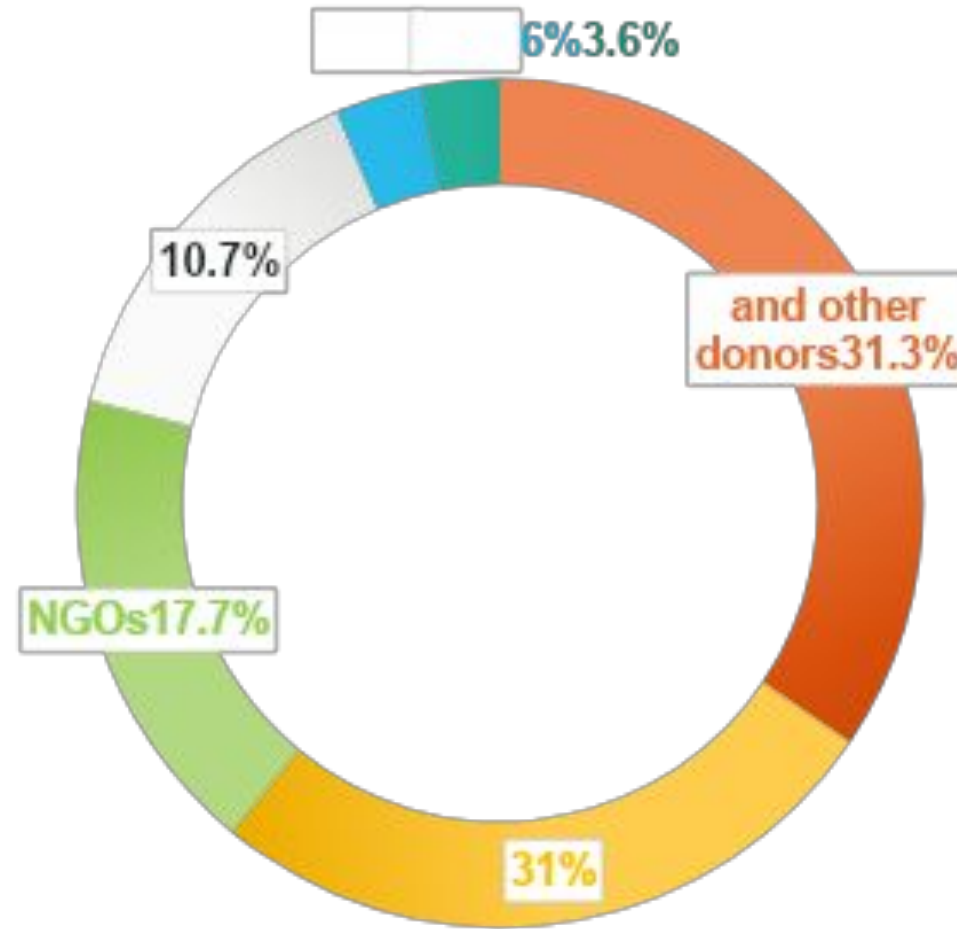
# Total funding approved by strategic objectives across the three regions (EUR million) AR 2023



The breakdown of approved funding by strategic objective as of the end of 2023 is the same as in 2022:

- **45%** for actions to strengthen the resilience of affected communities and promote economic and employment opportunities;
- **31%** for actions to improve migration management;
- **22%** for actions to improve governance and conflict prevention.

## Monitoring and learning systems

2 reports were published for each region:

- an annual report covering 2022
- a report covering the first half of 2023
- a total of 217 Result-oriented monitoring review completed to date

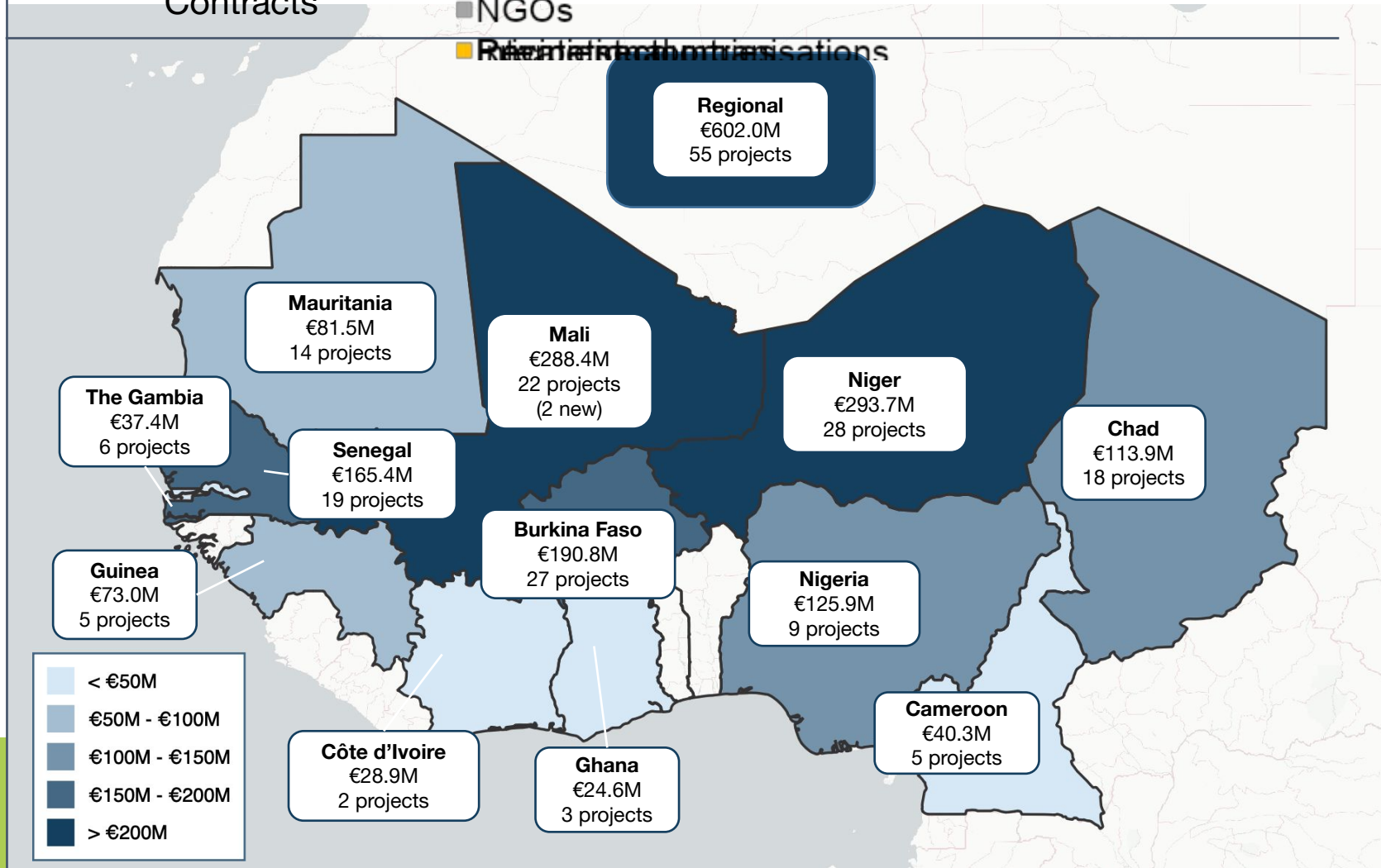

## RESULTS - Sahel & Lake Chad (S1 2023 and cumulative)

### SO 1 Greater economic and employment opportunities

- 11,087 **jobs created**, overall 149,852 jobs created and supported
- 25,890 people assisted to develop **income generating activities**, overall 556,622 IGAs supported
- 22,826 people benefitted from **professional training/skills development**, in total 310,723

### SO 2 Strengthening resilience of the most vulnerable communities

- 151,211 people received **nutrition assistance**, 2.4 million total
- 117,942 people received **food security-related assistance**, 3.1 million overall

## Sahel & Lake Chad (S1 2023 and cumulative)

### SO 3 Improved migration management

- 1,236 people on the move assisted, bringing the total to 212,889
- Almost 3 million potential migrants reached by **information campaigns on migration**, 21 million in total

### SO 4 Improved governance and conflict prevention

- 1.4 million individuals participated in **peace-building activities**, for a total of 6.3 million
- Training on **governance and conflict prevention** provided to 11,520 individuals, 90,404 total

# Impact assessment of EUTF SO1: Increase economic and employment opportunities in the SLC

**OS1: Use of quantitative approaches (experimental and quasi-experimental).**

**R1:** 7 counterfactual impact evaluations (including 5 in the SLC window and 2 in HoA ) + 2 purely qualitative studies (SLC).

**OS2: Use of a mixed approach .**

**R2:** 48 decisions and 84 portfolio contracts + triangulation with lessons from R1.

**SO3: Influence on policies.**

**R3:** Raising awareness and sharing knowledge about impact assessments.

**SO4: Capacity development.**

**R4:** Awareness of impact evaluations.
